

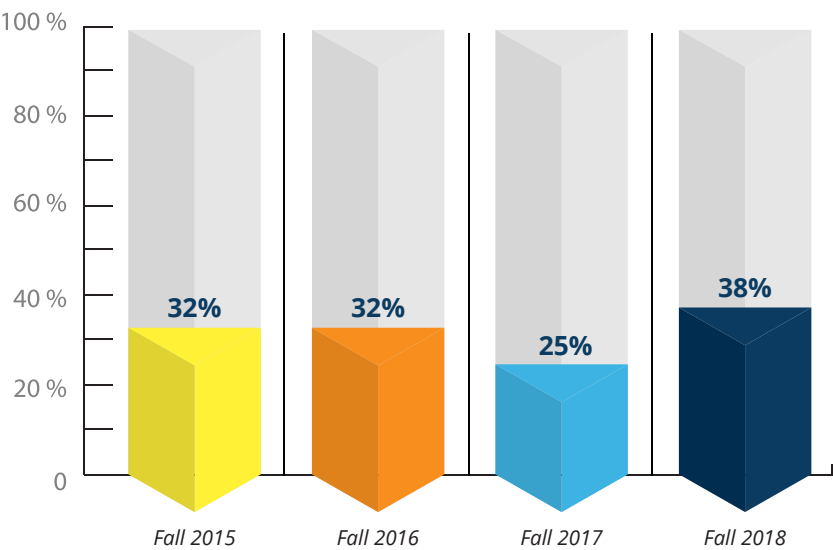
SACSCOC Accreditation

As of December 2018, Richmond Graduate University was reaffirmed by the Southern Association of Colleges and Schools Commission on Colleges to award Master's degrees.



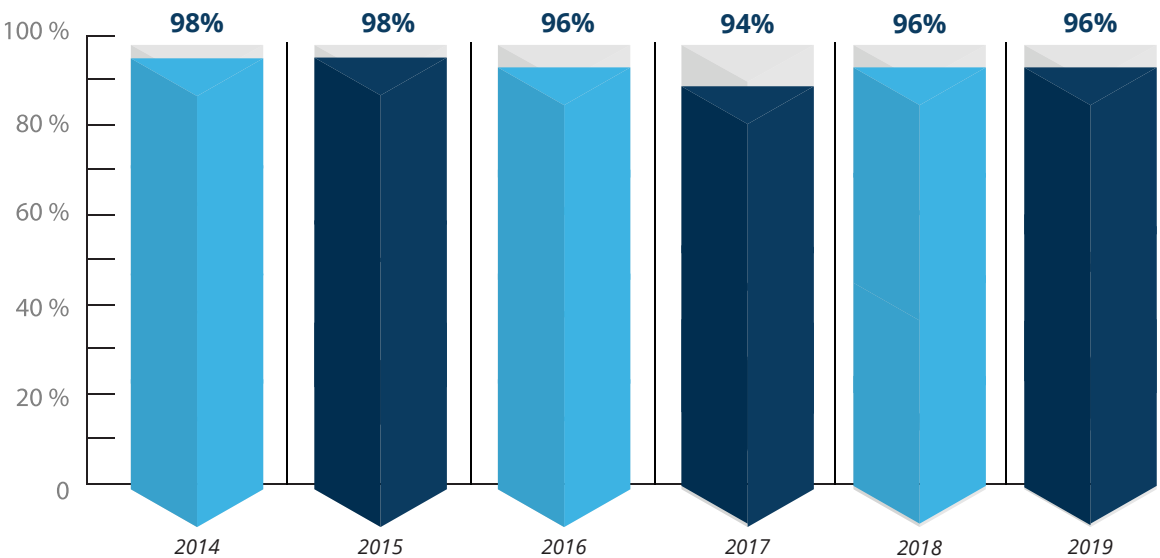
Diversity

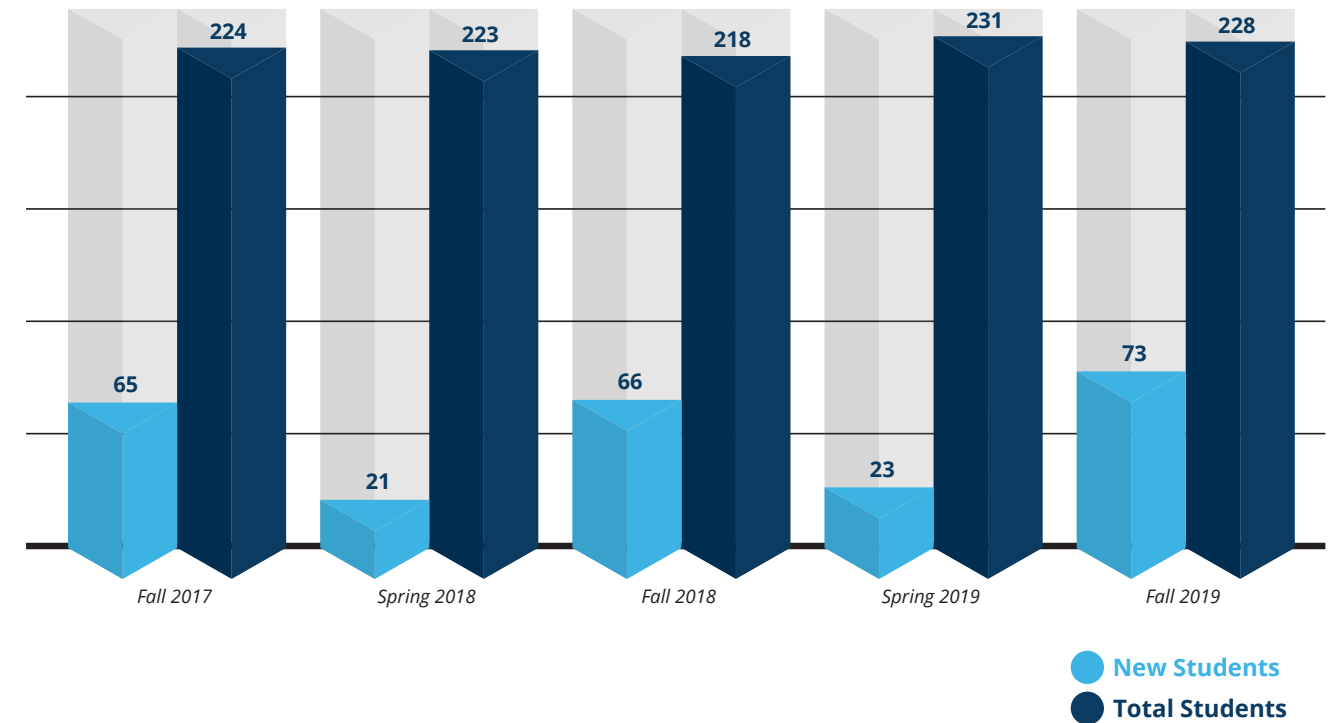

School of Ministry

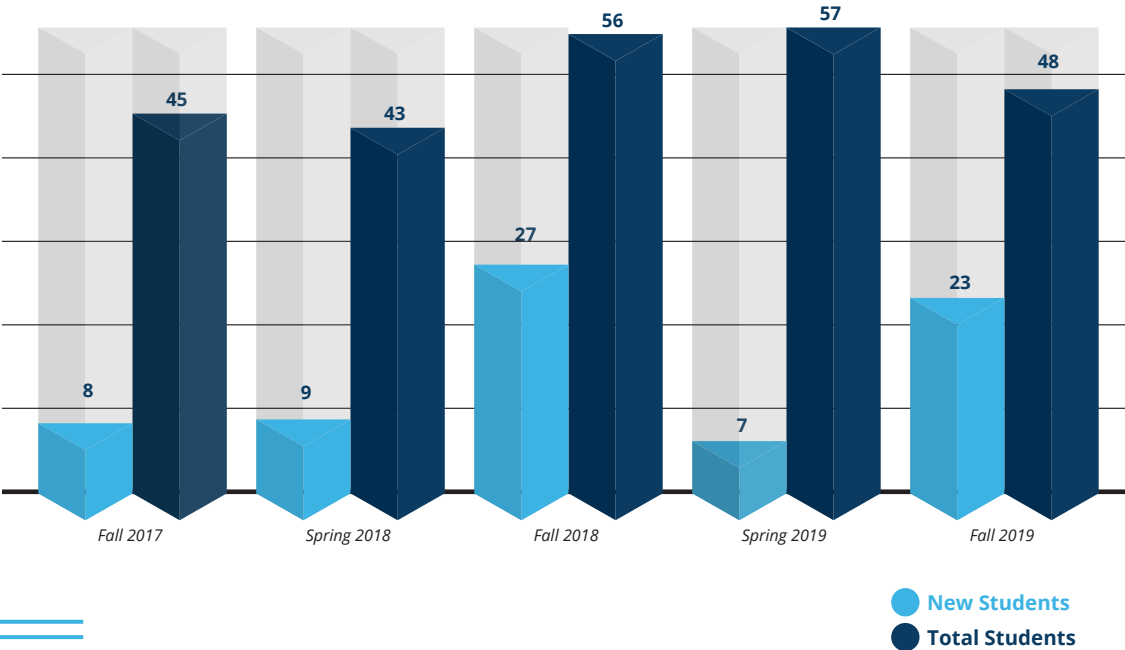

New Partnerships:

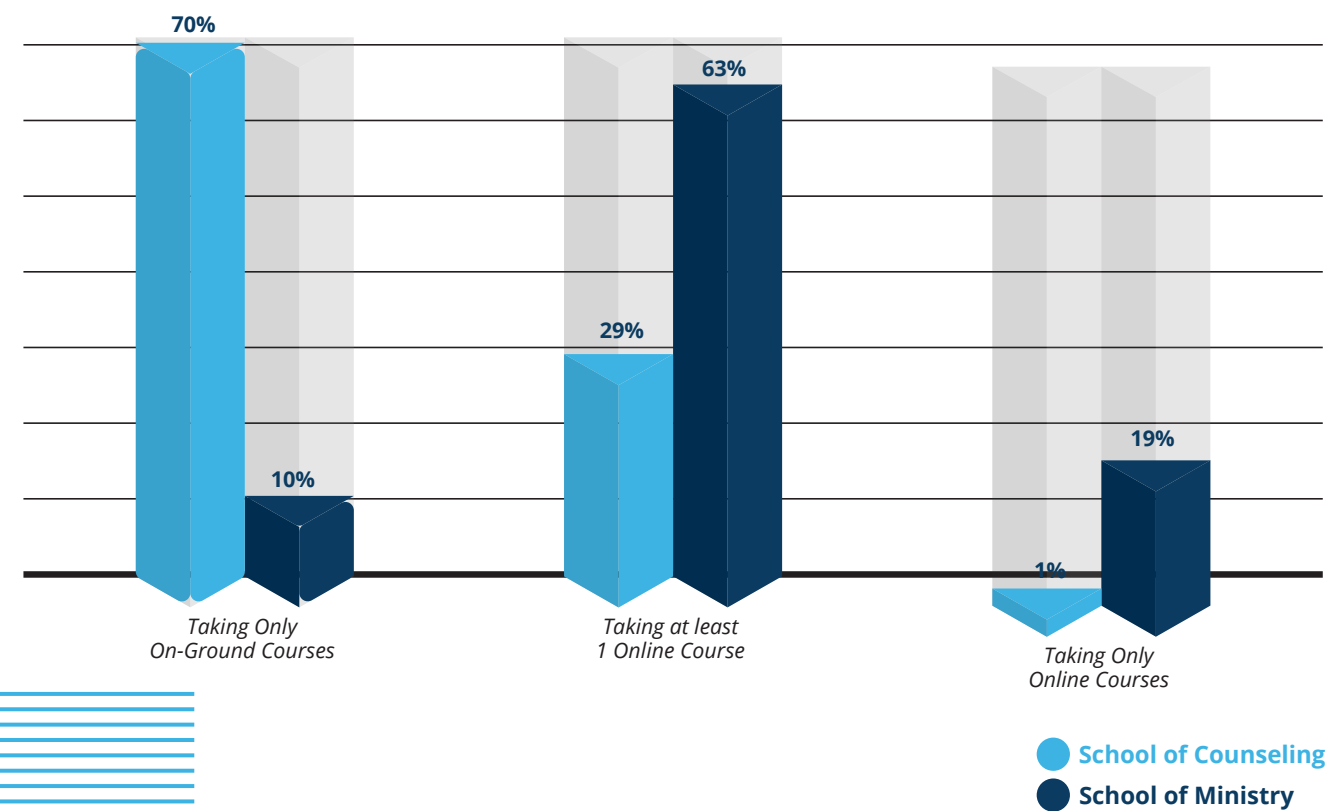
Recently, the School of Ministry signed an Articulation Agreement with the Timothy Team National Pastors Network, which provides advanced standing into the Master of Arts in Ministry.



Online Campus

The emerging Online Campus continued to gather momentum and grow enrollment. With the Georgia Nonpublic Postsecondary Education Commission’s (GNPEC) approval of Richmond’s online campus, approximately 40% of the Clinical Mental Health Counseling curriculum is available for online delivery in distance learning format, whereas 100% of the Master of Arts in Ministry distance learning format is available now.

As of Spring 2019, 30% percent of School of Counseling students were able to take advantage of online coursework. Plans have been made to begin a search for the inaugural Program Director, as well as the first core faculty member dedicated exclusively to the Online Campus, exclusively for the School of Counseling online curriculum, with hiring to occur in early 2020. As we continue to expand our online presence, students can take advantage of our multiple course offering modalities.



2019 Commencement

Richmont's forty-sixth commencement was held on May 11, 2019 at Ridgedale Baptist Church in Chattanooga, Tennessee. This year's commencement address was delivered by Dr. Rhonda Milner. Dr. Milner serves as a member of our Board of Trustees and is an alumna who graduated from both the School of Counseling and the School of Ministry.

Each year at graduation, one alumnus/a is honored with the Distinguished Alumni Award, recognizing outstanding professional achievement and/or service to Richmont. This year's winner was Don Davis '06. Additionally, each year a staff member is honored with the Peterson Award, recognizing commitment and service to Richmont that far exceeds job demands or institutional expectations. The 2019 Peterson Award recipient was Gladys Edwards, longtime staff member at the Poindexter Library on the Chattanooga campus.

Faculty Spotlight

Dr. Keith Myers

What brought you to Richmond?

Several years ago my wife, Lavinia Myers '07, completed her Master's degree with Richmond (it was Psychological Studies Institute at the time). So my first introduction to RGU was through her and hearing her talk about the program and the excellent teaching and clinical training she received. She spoke highly about the community and how professors and staff poured into her life, and it really struck me at the time.

Then a few years later I decided to pursue my Ph.D. Shortly into that process, I became an Approved Clinical Supervisor, and I was invited by Dr. Snyder to be a clinical supervisor for Richmond. I was honored to serve a few students in this role as I finished my Ph.D. During my doctoral program, I was always mindful and prayerful about where I would land in academia. I really did not consider that it could be Richmond since several things would need to come together for that to happen.

I will never forget the night I was sitting at home in my study room scouring the academic job postings. And then I saw the unexpected – it was a posting for an Assistant Professor job with Richmond! I might have let out a staccato shout when I saw it, and Lavinia came running in curious and asking me what had happened. Today I'm happy to call RGU my first academic home, a place I hope will be home for years.

Now that you have been here 3 ½ years, what are your favorite Richmond memories?

A couple of times come to mind. One was during the Summer of 2018 when I was teaching Human Growth and Development. It was the day of the final exam, and I could sense that many were anxious due to the large amount of content covered. I felt prompted in the moment to pray individually for each student. I thanked God how each one of them brought their uniqueness to the class and identified each person's strengths. Most of the class told me how powerful that moment was for each of them, and I was grateful that God was present in the moment and I was able to be used in a personal way to encourage our students. It was fun because some students didn't tell me until months afterward how meaningful those moments were.

The second, now that I think about it, isn't really a memory but more of gratitude for being able to advise students. I have a passion for advising students and encouraging them along in their wellness journey, and in their personal and professional development. Advisement week has really added to the depth of how I advise students, and I'm grateful for the opportunity.

What sets Richmond apart from other programs?

The first answer is an easy one. It's the community here. The community among the faculty, the staff, and the students is close and people like being here. Some students don't only find Richmond as their alma mater, but they make lifelong friends and mentors for their development as humans and counselors. I've found people I can call friends, and in my mind having a couple of good friends at the workplace is a gift from God Himself.

The second is our clinical program. Anecdotally, I was at the ACA conference back in the Spring, and I met a few Ph.D. students from another local counseling program. Once they found out I was a professor at Richmond, they all commented, "Richmont students really know how to have a presence with clients." I must admit that inside I was smiling proudly! That sentiment is true. Not only from our focus on the person of the therapist, but also on our requirement for all students to work at a minimum of two clinical sites (HOPE & Outplacement) These are what make Richmond stand out from other programs.

Tell us a little about yourself?

Personally, I was born in Maryland, but grew up in Ohio. And it's true that you can take the man out of the Buckeye state, but you can't take the Buckeye out of the man. Go BUCKS! I've lived in Atlanta since 2007, so I am starting to feel like Atlanta is the place I call home for most of my adulthood. And feeling like this has become home, I've adopted the local teams of the Braves and Falcons as my own, which I have also



slowly accepted the disappointing fate of being an Atlanta sports fan and everything that implies. On a brighter note, Go ATL United!

As I mentioned earlier, my wife is an alum of Richmond. People often ask us, “How does that work in your marriage both being counselors?” For us, it’s been quite a gift. We get each other as helpers and understand the work we do and for us it’s been something that draws us together.

Being a fairly new dad over the last 2.5 years has been such a joy! Our son, Luke, has been such a gift, and this new identity gives me such meaning and purpose that is impossible to duplicate. I’ve learned so much more about myself as a person, about myself as a teacher, and about God Himself through the experience of being a “Dada.” It’s hard to explain how that all comes together, but it does.

Recently, I have experienced loss in my personal life and I’ve been noticing an invitation from the Lord to have a different relationship with Him. Well, I guess it’s not a different relationship, but a series of different rhythms within that same relationship – one that’s marked by silence and solitude and Sabbath. I’ve also started spiritual direction and that’s something I have never done before. So that’s been a reassuring experience, knowing that in the midst of unexpected hard times is when God is asking me to draw closer in newer ways that I didn’t expect.

Congratulations! Recently, you were promoted to Associate Professor and Dean of Clinical Affairs. What do these roles mean to you?

How much time do we have? I’m kidding. I can be brief, I think. Joking aside, Associate Professor means so much to me. We have a funny story in our home that my wife recalls when I was in my doctoral program while taking courses, publishing, and presenting at conferences. She demonstratively declared, “You’re much more of a nerd than I realized!” I still want to believe that she was complimenting me! It is fun realizing you’ve found your niche or professional identity, and I think what my wife was implying was that I’ve found my place. It actually took me a lot longer to find this place – I was 11 years in the field before starting my Ph.D. so it’s nice to feel like I’ve come home. Home is coming up a lot for me as we are discussing this. Teaching, scholarship, service to the profession, and advising comes natural to me and doesn’t feel like hard work. I love this role, and I hope to be in it for a very long time.

Regarding Dean of Clinical Affairs, I’m thankful for those who have gone before me. Dr. Evalin Hanshew and Dr. Vanessa Snyder have set up things for our clinical program that make the transition a lot easier. So I’m grateful for them and especially Vanessa. She continues to be available to me as she mentors me in this role. Also, I love working with the interns. Love seeing them expect internship to be one thing, and then realize midway or at the end (or even years after their degree) that it was very different than they thought and those were unexpected gifts in their development as a person and a counselor. Love seeing their growth as they enter personal therapy which empowers them to be able to sit better with clients. And it’s a responsibility that I don’t take lightly and pray that I never will.

I’m realizing we are discussing everything on many levels Richmond feels like home. I hope it will continue to feel that way for staff, faculty, and students as we band together to serve people in their hardest times—to be a light in the darkness, to bind up the broken hearted, and to be the city on a hill.

The work of Richmond Graduate University is made possible through a network of generous donors. The fiscal year of 2019 saw growth in many areas and the launch of several new development initiatives.

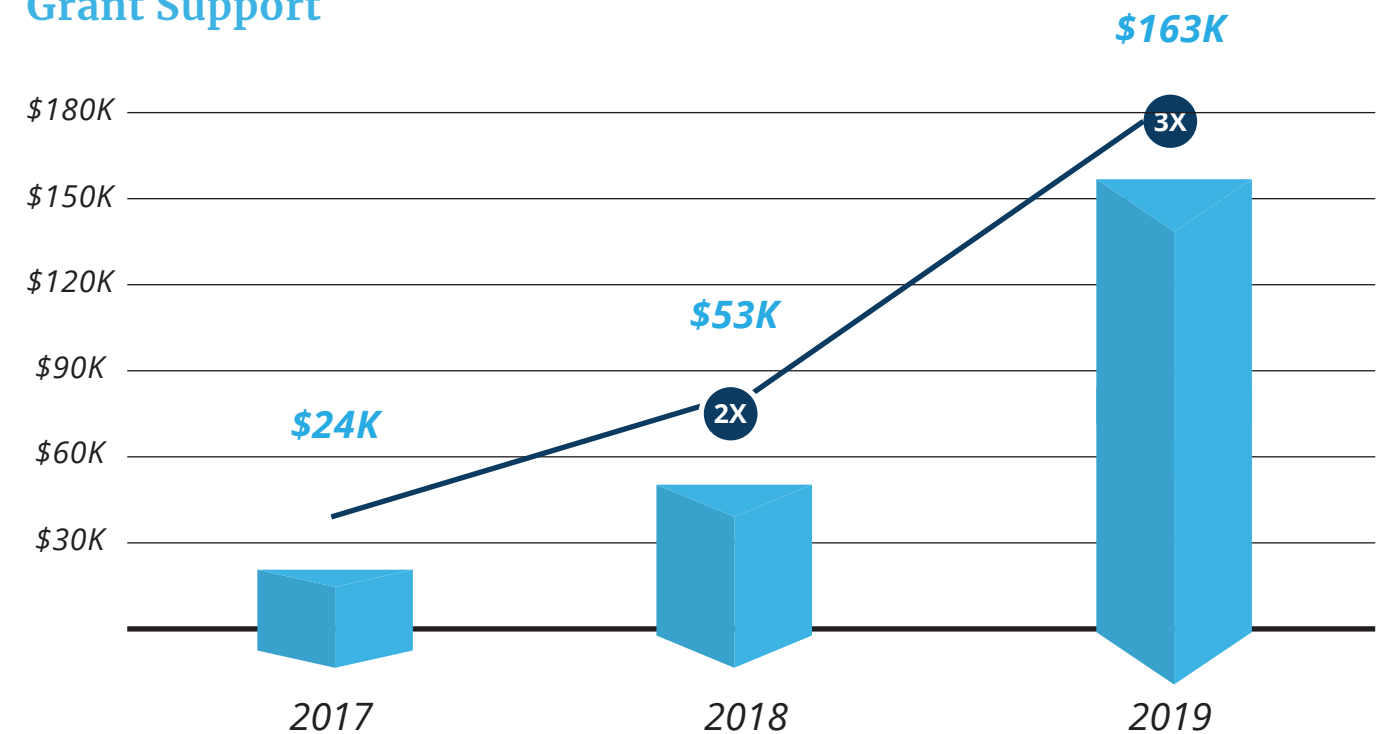

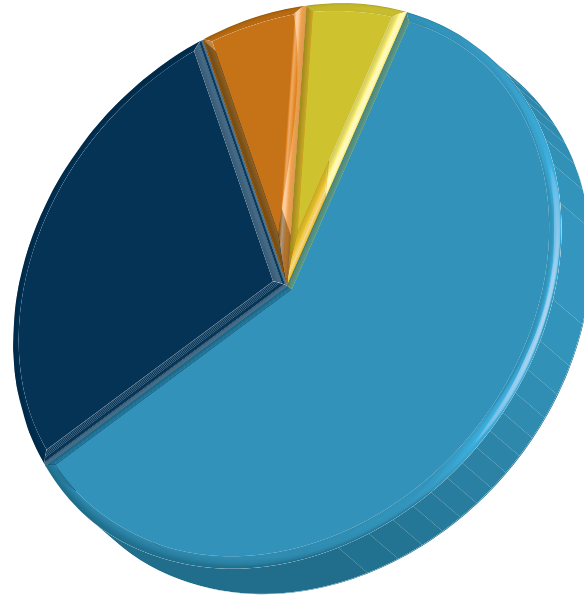
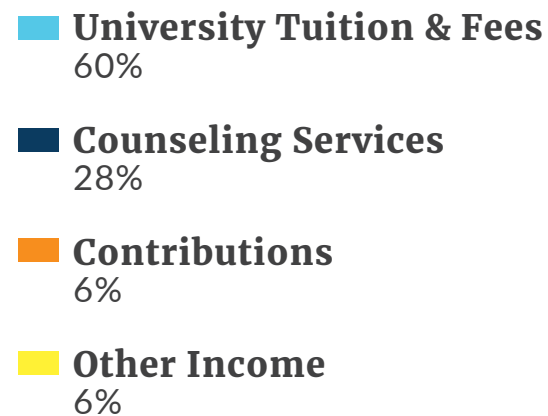
